ORDINANCE NO. 2022-2

AN ORDINANCE PROVIDING FOR THE SUSPENSION OF THAT PORTION OF ORDINANCE 2011-6 WHICH CALLS FOR THE ANNUAL INCREASE BY 3% OF THE AMOUNTS CHARGED FOR WATER IN TABLE 1 AND TABLE 2 FOR CUSTOMERS WITHIN THE CORPORATE LIMIT AND FOR CUSTOMERS OUTSIDE THE CORPORATE LIMIT AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the Village of Arcadia, Ohio, two-thirds of all members elected thereto concurring, that:

WHEREAS, the Village has determined that a loan to complete a water line through Ohio Water Development Authority will be completed in 2022; and

WHEREAS, the final payment for the water line loan will reduce expenses to the water department; and

WHEREAS, the Village has confirmed that it is not necessary at this time to increase the amount it charges its customers for the year 2022 in order to meet the cost to supply water to the community; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE MUNICIPALITY OF ARCADIA, OHIO, THAT:

That portion of Ordinance 2011-6 which calls for the annual increase by 3% of the amounts charged for water in Table 1 and Table 2 for customers within the Corporate Limit and for customers outside the Corporate Limit is hereby suspended. The amount to be charged customers effective March 15, 2022, shall be the same rate as was being charged prior to March 15, 2022.

.This Ordinance is hereby found to be necessary to serve the public peace, health, and safety of the inhabitants of the Village, and as such shall be passed as an emergency measure.
