AN ORDINANCE PROVIDING FOR THE AMENDMENT OF SECTION THREE (3) AND SIX (6) OF ORDINANCE 2011-6 AS RELATED TO THE USER CHARGES FOR THE WATER DEPARTMENT OF THE VILLAGE OF ARCADIA AND AS WELL TERMINATING THE SUSPENSION OF THE INCREASE OF THE WATER RATES AS PROVIDED FOR WITHIN ORDINANCE NUMBER 2022-2 AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the Village of Arcadia, Ohio, two-thirds of all members elected thereto concurring, that:

WHEREAS, the Village has determined that it is necessary to increase the amount it charges its customers at the present time in order to meet not only the effects of inflation, the costs of maintenance and repair, but as well the increase in cost of water charged by the City of Fostoria;

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE MUNICIPALITY OF ARCADIA, OHIO, THAT:

Section 3 and section 6 of Ordinance 2011-6 shall be amended to provide as follows:

SECTION 3: The current amounts charged for water in Table 1 and Table 2 (as provided for in legislation issued by the Village of Arcadia) shall increase by six percent (6%) effective with the bills due on October 15th, 2022. The amount charged for water in Table 2 shall be calculated at one hundred and twenty-five percent (125%) of the currently charged rate for Table 1. This six percent (6%) increase shall continue until changed by the Village of Arcadia.

SECTION 6: Bulk water may be provided by special agreement with the Village. Such water will be provided at times and locations designated by the Village Administrator. Bulk water is currently being billed at a rate of \$11.22 per 1000 gallons. This rate shall increase by six percent (6%) effective with the bills due on October 15th, 2022. Any labor required by village employees will be billed in addition to the cost of water.

This Ordinance is hereby found to be necessary to serve the public peace, health, and safety of the inhabitants of the Village, and as such shall be passed as an emergency measure.
