VILLAGE OF ARCADIA HANCOCK COUNTY OHIO

RESOLUTION 2022-K

A RESOLUTION: REQUESTING THAT THE COUNTY AUDITOR CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE TAXING AUTHORITY AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A 2.8 MILL TAX LEVY ON THE PROPERTY WITHIN THE VILLAGE OF ARCADIA, OHIO PURSUANT TO OHIO REVISED CODE SECTION 5705.03 AND DECLARING AN EMERGENCY

WHEREAS, the amount of taxes that may be raised within the 10-mill limitation will be insufficient to provide for the necessary requirements of the Village of Arcadia, Hancock County, Ohio, and it is necessary to levy a tax exceeding the limitation for the purpose of providing funds for replacing, repairing, maintaining, and improving the current storm drainage system of the Village, as provided for in Section 5705.03 of the Ohio Revised Code.; and

WHEREAS, it is the desire of the Council to enact a tax levy resolution and authorize the placement proposed levy is a replacement of an existing 2.3 mills outside the 10-mill limitations of an existing levy and an increase of 0.5 mills, to constitute a tax for the benefit of the Village of Arcadia, Hancock County, Ohio for the purpose providing funds for replacing, maintaining, and repairing the storm drainage system of the Village at a rate not exceeding 2.8 mills for each one dollar of valuation, commencing in tax year 2022, first due in calendar year 2023 It is the desire of this council to include the levy upon the ballot at the election to be held November 8th, 2022 at the usual voting places within the said village in accordance with the Ohio Revised Code Section 5705.19 and 5705.192. The replacement levy will constitute a tax of 2.8 mills for each dollar valuation, which amounts to \$0.28 for each \$100.00 valuation.

NOW, THEREFORE, BE IT RESOLVED by the council of the Village of Arcadia, Hancock County, Ohio, two-thirds (2/3) of all members elected thereto concurring that:

SECTION 1: That the Hancock County Auditor be and the same hereby is requested to certify to said taxing authority the total current tax valuation of the taxing authority and the dollar amount of revenue that would be generated by a 2.8 mill tax levy on the property within the Village of Arcadia, Ohio

SECTION 2: That the Fiscal Officer for the Village of Arcadia, Ohio and she is hereby directed to certify a copy of this Resolution to the Hancock County Auditor in accordance with Ohio Revised Code 5705.03

SECTION 3: The proposed levy is a replacement of an existing 2.3 mills outside the 10-mill limitations of an existing levy and an increase of 0.5 mills, to constitute a tax for the benefit of the Village of Arcadia, Hancock County, Ohio for the purpose providing funds for replacing, maintaining, and repairing the storm drainage system of the Village at a rate not exceeding 2.8 mills for each one dollar of valuation, which amounts to _____ for each one hundred dollars in valuation for five years, commencing in tax year 2022, first due in calendar year 2023 It is the desire of this council to include the levy upon the ballot at the election to be held November 8th, 2022 at the usual voting places within the said village in accordance with the Ohio Revised Code Section 5705.19 and 5705.192. The replacement levy will constitute a tax of 2.8 mills for each dollar valuation, which amounts to \$0.28 for each \$100.00 valuation.

SECTION 4: The levy shall remain in effect for five (5) years, commencing with the first collection to be made in 2023, pursuant to section 5705.03 and 5705.19 and 5705.192 of the Ohio Revised Code.

Section 5: The Village therefore provides that the Clerk shall certify a copy of this resolution to the Board of Elections of Hancock County for inclusion on the Ballot not later than August 10, 2022 and request the Board to provide for notice of the election as required by law.

SECTION 6: This Resolution passed in regular session this 8th day of August 2022. Further this resolution is passed and necessary for the protection of the public health, safety, and for the prompt and legal


