## ORDINANCE NO. 2024-6

**AN ORDINANCE PROVIDING FOR THE REINSTATEMENT OF MARK BOWMAN AS THE VILLAGE ADMINISTRATOR FOR THE VILLAGE OF ARCADIA, OHIO UPON THE SAME TERMS AND CONDITIONS AS PREVIOUSLY ESTABLISHED AND DECLARING AN EMERGENCY.**

Be it ordained by the council of the Village of Arcadia, Ohio, two-thirds (2/3) of all members elected thereto concurring, that:

WHEREAS, on April 15, 2024, the Village Council met in regular session. During said session, the Village Administrator, Mark Bowman, submitted a letter of resignation. Village Council did not act upon the letter of resignation at that time.

WHEREAS, on April 23, 2024, Village Council met for a special scheduled session. During this special scheduled session, the Village Council voted to reinstate Mark Bowman as the Village Administrator upon the same terms and conditions as previously established.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE MUNICIPALITY OF ARCADIA, OHIO, THAT:

Section 1. That Mark Bowman is reinstated to the position of Village Administrator upon the same terms and conditions as previously established without modification. This shall become effective with his return on April 24, 2024.

Section 2. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, the daily operation of the Village, and to maintain the employment of the Village Administrator.
