## **RESOLUTION 2024- G**

## A RESOLUTION AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR TO PURCHASE TWO SOLAR SPEED AWARE RADAR SPEED SIGNS THROUGH TREETOP PRODUCTS AND DECLARING AN EMERGENCY.

WHEREAS, On June 10<sup>th</sup>, 2024 the Village Administrator notified the Village council that Arcadia Local School was interested in having a radar speed sign to monitor the speed of traffic on State Route 12 in front of the school; and

WHEREAS, the Village Administrator has informed council that Arcadia Local School has agreed to pay for one of the signs; and

WHEREAS, the quote for 2 radar speed signs with shipping is \$4,698.66(four thousand six hundred ninety-eight dollars and sixty-six cents; and

WHEREAS, the school has agreed to reimburse the village for the cost of one of the speed signs and the village will install the sign on State Route 12,

Whereas, the price savings for two was worth the additional speed sign; and

WHEREAS, the additional sign may be placed in another section of town that would benefit from speed awareness,

WHEREAS, the quote for 2 radar speed signs with shipping is \$4,698.66(four thousand six hundred ninety-eight dollars and sixty-six cents the Village Council finds said bid to be reasonable;

NOW THEREFFORE, be it resolved by the Council of the Village of Arcadia, Ohio:

- Section 1: That the Village Administrator be authorized and directed to purchase 2 solar radar speed signs with shipping for \$4,698.66 (four thousand six hundred ninety-eight dollars and sixty-six cents from TreeTop Products,
- Section 2: It is found and determined that all deliberations and actions of Council concerning and related to the passage of this Resolution were held in meeting open to the public in compliance with all legal requirements including section 121.22 of the Ohio Revised Code.
- Section 3: That this Resolution is declared to be an emergency measure necessary for the immediate preservation of peace, health and safety of the Village.
