

## **ORDINANCE NO. 2025-7**

### **AN ORDINANCE PROVIDING FOR THE EMPLOYMENT OF AMIE CLOUSE AS VILLAGE FISCAL OFFICER/ VILLAGE CLERK FOR THE VILLAGE OF ARCADIA, OHIO AND APPROVING THE VILLAGE CLERK/ FISCAL OFFICER'S RESIDENCE OUTSIDE OF THE VILLAGE OF ARCADIA AND DECLARING AN EMERGENCY.**

Be it ordained by the council of the Village of Arcadia, Ohio, two-thirds (2/3) of all members elected thereto concurring, that:

WHEREAS, on December 8, 2025, the Village Council voted to approve an employment contract for Amie Clouse as the Village Fiscal Officer/ Village Clerk and approving the Village Clerk/ Village Fiscal Officer's residence outside of the Village of Arcadia; and

WHEREAS, Council continues to find it to be in the best interest of the Village of Arcadia to employ a Village Fiscal Officer/ Village Clerk and to provide for Ordinances approving said contract of employment;

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE MUNICIPALITY OF ARCADIA, OHIO, THAT:

Section 1. That Amie Clouse, pursuant to the contract agreed upon between the Village of Arcadia and Amie Clouse, shall be employed as Village Fiscal Officer/ Village Clerk pursuant to said contract.

Section 2. The Village Fiscal Officer/ Village Clerk, so employed, shall receive compensation pursuant to the written contract for services rendered as executed, and approved this 8<sup>th</sup> day of December, 2025.

Section 3. The Village Council approves the village clerk/ fiscal officer's residence outside of the Village of Arcadia.

Section 4. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, the daily operation of the Village, and to maintain the employment of the current Fiscal Officer/ Village Clerk, Amie Clouse.
